- * Safety helmets and heeled boots required when mounted.
- * Dressage whip no longer than 47" – Approved bits must be used.
- * No refunds unless show is cancelled.
- * Food available on grounds.
- * **All horses shown out of trailer** – unless stall is rented.
- * Ribbons to 6 places.
- * All shows in 1 Ring only, entries taken until show is full.
- * A horse/rider combination may not show the same test twice.
